The Government of the Republic of Liberia through the Liberia Medicines and Health Products Regulatory Authority (LMHRA) intends to apply part of its budgetary allocations from its GOL Budget and Internal revenue generation Budgets for fiscal year 2026 for the procurement of **Vehicle repairs & maintenance services**.

The LMHRA now invites sealed bids from eligible registered bidders to provide **Vehicle repairs & maintenance services** for FY2026.

Bidding will be conducted through the **National Competitive Bidding** process, a procedure specified in the PPCA and approved by the PPCC and is now open to all bidders.

Qualification requirements include:

- ✓ Valid tax clearance

- ✓ Evidence of PPCC Vendor registration
- ✓ Bid Security / bid securing declaration

A complete set of bidding documents in English may be purchased by interested Bidders from the Procurement Unit of LMHRA upon a payment of a nonrefundable fee of US\$50 For each set from February 18, 2026, from 9:00am to 4:00pm, Monday to Friday.

All bids must be accompanied by a bid security.

Sealed bids must be delivered to the Procurement Unit of the LMHRA no later than 12:00pm on March 18, 2026. Bids shall be valid for a period of 30 days after the deadline for submission of bids. Electronic bidding will not be permitted. Late bids will be rejected and returned unopened.


Bids will be opened in the presence of bidders or their representatives who choose to attend in the Conference Room of LMHRA on March 18, 2026 at 12:30 pm.
