# Call for Expression of Interest (EOI)

The Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH, under the multidonor partnership Energising Development (EnDev), invites organizations to submit an EOI for the role of Independent Verification Agent (IVA) for the implementation of a Results-based Financing (RBF) programme in Liberia which address the following objectives.

- Role of the IVA: The IVA will verify whether connections/sales claimed by a company were
  actually made using phone and field verification. The IVA is expected to make available
  verification agents as needed to conduct interviews with customers on the phone and in the
  field using questionnaires and survey tools provided.
- <u>Duration</u>: The IVA will be contracted for a period from 1<sup>st</sup> November 2023 to 31<sup>st</sup> August 2024 with a possibility of extension. It is estimated that up to 390 expert days will be required to verify up to 4,400 cases.

About: This RBF will help solar home system (SHS) companies to cover high distribution costs faced when serving communities in remote, rural areas, as well as to overcome affordability challenges through enabling them to offer lower end-user prices. Results-based financing is a financial incentive to private companies that is paid once results are proven.

The EOI is the first stage of a multi-stage tender process. The objective of the EOI process is to identify and pre-register organizations that are interested in entering into the proposed contract and have suitable capacity, capability and experience. Only shortlisted candidates, fulfilling the below requirements, will receive the full terms of reference (ToR) and will be asked to submit a full proposal.

EOI must be submitted by email to <u>LR Quotation@giz.de</u> and submitted no later than the **4**<sup>th</sup> **of September 2023**. **NOTE:** Kindly mention "**83446403 EOI IVA**" in Email Subject line otherwise it may be rejected. The maximum email size is 15 MB per email.
