- 1. The National Port Authority has received funding from its 2025 Budget and intends to apply portion of the funds towards the construction of a 3-storey office building in Buchanan, Grand Bassa County.
- 2. The National Port Authority (NPA) now invites sealed bids from eligible and qualified bidders for the construction of a 3-Storey Office Building.

 - Article of Incorporation
 - Valid Business Registration
 - Valid Tax Clearance
 - Valid PPCC Updated Vendor Certificate
 - valid Ministry of Public Works Certificate
 - Valid ALCC Certificate

- 8. Late Tenders will be rejected. Bids will be opened physically on Monday, October 29, 2025 at 12:00 pm in the Conference Room of the National Port Authority, in the presence of the Bidders or bidders or representatives who choose to attend in person.
- 9. All bids must be accompanied by a Bid Security in the form of a bank guarantee (2% of total bid price) from a local bank.
